3	Iremongers Pond Update	
3.1	BA – Meeting with NCC, EA and Notts Wildlife, have a scheme called 'Rewilding the Trent' which is going to be focused in Clifton and Wilford. Budget is potentially 17k. Showed them the orchard, then to the bridge and the badger set, talked about clearing an extra bit of path. Seemed happy and should be able to improve habitat. Discuss cutting back some trees and talked about cleaning out the excess reeds in the swales and tidying up what is there. Empty land may have wildflowers planted. Improving the bridge has been agreed.	
	This is the first steps and may be a while off yet. Sophia Kourpas at NCC is coordinating the project.	
	Remote updated from DA – have been able to get agreement between all involved for bridge heightening. The Environment Agency and Council are both finally happy with our plans. Pino (at Bridgeways) has very generously agreed to install the bridge, and we've enlisted a local engineer to sign off on the plans. Progress will hopefully come as soon as the weather is improved.

4.1	PD – Everything was frozen so was difficult however average volunteers is about 6 people.	
5	Flooding	
5.1	SB - Closed the road quickly due to a system in place. NCC did not respond quickly so the police closed. Diversion signs were put in place along with flood signs being put up. SB setting up a group to see if we can get the system up and running quicker by holding the signage locally. Meeting with Severn Trent to look at the flooding timeline. Aldi have illegally connected to their sewers, this is being investigated as Aldi over pumped when flooding happened previously.	
	Everyone has agreed to a drop-in session for all the agencies included the NET. This will be in the spring in the daytime. NET put up a story to say spending 200k on ballast, during this flood event it was said they did not turn off the pumps, but they did.

	BA – There is a stream in a pipe at the back of Vernon Avenue in the 1940s and the NET contractors said it is not on the drawings so ignore it, which they did and had to then pump out the water.	
	JM – There are no drain plans on Holly Avenue. Please give them a heads up there is a water course and it will be raised in the planned meeting.
